IN COMPLIANCE WITH ORDINANCE NO. 33 AND RESOLUTION NO. 489 OF THE TOWN OF CLARKDALE, I HEREBY REQUEST A PERMIT FOR THE KEEPING OF LIVESTOCK, POULTRY AND/OR OTHER SMALL ANIMALS WITHIN THE TOWN.

GENERAL PROVISIONS: In any subdivision where deed restrictions exist, such deed restrictions shall be honored. The permit holder shall agree to periodic inspections by the Town Marshall or his authorized agent of the special property covered by this permit. Failure to correct deficiencies in sanitation and/or other requirements within (30) days of the first warning may result in suspension or revocation of this permit.

REGULATIONS: Livestock (Horses, Cows, etc.): Two (2) animals per acre on a lot of not less than one acre. Poultry and other small animals: One (1) animal per each one thousand square feet of property and not less than 10,000 square feet. Animals of this type shall be kept in such a manner as to prevent their running at large (penned or high, tight fence). Male poultry is to be kept voiceless or crowless.

NOTE: THE TOWN OF CLARKDALE ZONING CODE ONLY ALLOWS LIVESTOCK IN THE TOWN LIMITS BEING RAISED FOR COMMERCIAL OR PROFIT AS A PRESCRIBED USE IN THE RS3 ZONING DISTRICT. PERSONS WISHING TO RAISE LIVESTOCK FOR THESE PURPOSES SHOULD DISCUSS THE MATTER WITH THE COMMUNITY DEVELOPMENT DIRECTOR.
